**GENERAL LIABILITY WAIVER AND HOLD HARMLESS AGREEMENT
FOR FACILITY USE AT HOLY CROSS CROATIAN RC PARISH**

I represent that I am a legal, responsible adult. I represent and warrant that I am signing this document for myself and my children as to any facility usage on Holy Cross Croatian RC Parish property as well as any facility usage on Croatian Sports and Community Center property to include, but not limited to, the upper and lower hall, indoor and outdoor spaces, as well as the place of worship. I am fully aware of the risks and dangers of such usage.
